## **Section 4 - First Aid Measures**

### **General Information:**

### Section 6 - Accidental Release Measures

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. # Section 7 - Handling and Storage
